APPENDIX A: MEMBERSHIP CATEGORIES

The categories of membership in the Kivalliq Chamber of Commerce, as described in Section 2.1 of the Chamber's by-laws, are:

a) Category 1 (Voting Members):

- Any business located in or registered in the Kivalliq Region or Nunavut.
- Any organization located in the Kivalliq Region that supports the goals and objectives of the Kivalliq Chamber of Commerce and does not fall into Category 3.
- The seven Kivalliq Hamlets.

b) Category 2 (Voting Members):

- Any business located or registered outside of Nunavut, which does substantial business in or with the Kivalliq region.
- Any organization located outside of Nunavut that supports the goals and objectives of the Kivalliq Chamber of Commerce and does not fall into Category 3.

c) Category 3 (Non-voting Members):

- Government departments and agencies, public institutions, Inuit Organizations, and other non-profit, public, political, or governance organizations that have an interest in the activities of the Kivalliq Chamber of Commerce but do not themselves engage in business.
- Any organization acting as funders to the Kivallig Chamber of Commerce.
